EVENT APPROVAL: Iron Range Roll hosted by Connect Marquette, May 31, 2025: Kari Getschow, cochair for the event presented the dates and noted the same course as last year will be used with the race finishing in Marquette Township on the IOHT behind Menards; awards will again be held at Barrel & Beam; Johnson motions to approve the event permit; Becker seconds; ayes all
- VII. OLD BUSINESS

### A. Updates:

- Lakenenland Extension: Plans from Coleman Engineering have been submitted to the State of Michigan for approval; it was recommended that the IOHRA survey the trail corridor along the section of land in Section 10 where the owner has a small track of land with a trailer on it.
- IOHRA Board Appointments & Articles of Incorporation Update: Board representatives have been appointed by the 10 municipalities where the millage has been passed. Articles of Incorporation amendments need to be approved by each municipality which will be completed by April 10.

#### VIII. NEW BUSINESS:

- A. Maple Ridge Condominium, Negaunee IOHT connector: Mitch Nordahl from Maple Ridge condominium project in Negaunee has approached the IOHRA about creating a connector trail from the development to the IOHT on the east side of the property. It was discussed by the board to support the connector and take responsibility for the development and maintenance of the trail which would be on IOHRA land.
- B. Winthrop Jct Trailhead-Dan Perkins Property: Dan Perkins has rescinded his support for a multi-use parking lot off Washington Street that would be primarily used for ORV loading and unloading along with snowmobiles. It was discussed by the board to keep the lease agreement intact for future use if another opportunity presents itself to develop non-motorized trailhead parking on the site.

- C. City of Negaunee Property Lease for ORV/Snowmobile Parking Lot: the City of Negaunee would like to amend the lease with the IOHRA on the ORV parking lot proposal. They are still interested in persuing the campground and want to keep that portion of the lease intact. It is felt that the IOHRA or MiDNR would have a better chance of securing the funding for the trailhead parking lot. IOHRA board recommended that the City of Negaunee revise the lease with amendments and send it to the IOHRA board for review.
- D. Land Access Easement for Schwemin Property, Marquette Township: it is being requested by Marquette Township zoning & planning administrator to file a land division application for the 19.73 acres remaining with the Schewmin/Britton family. Hendrickson will with meet with Brian Sheridan, attorney, who worked on the acquisition with the IOHRA to see if this is needed. Hendrickson will report back to the board in March.
- IX. ADMINISTRATOR REPORT: IOHRA annual audit will be conducted by Anderson Tackman & Co. as required, Hendrickson is preparing the material from 2024 for review. Audit will be completed in March.
- X. BOARD COMMENT: Bussone indicated he will be gone for the next two meetings, but will be available via phone or email if needed; Hoffman asked if the IOHRA would be interested in participating in the Aspen Ridge School Community Night again this year, the board indicated there is interest, Hoffman will get the dates;
- XI. PUBLIC COMMENT: Jim Kippola, incoming Humboldt Twp IOHRA representative, indicated he is very much looking forward to serving on the board and indicated several potential projects for Humboldt Twp that could be incorporated in the IOHT trail plan; John Dulek, incoming Republic Twp IOHRA representative shared that the spillway construction at the Michigamme River dam site was completed and is a major accomplishment for the community.
